- 1.- Not be pre-enrolled in an official master's degree on the end date of scholarship registration.
- 2.- Not having access qualification for the academic year 2020-21.
- 3.- Not having completed the access qualification.
- 4.- Not having a foreign access qualification.

- 5.- Not reaching the average grade of 8 in the Spanish equivalency.
- 6.- Have residence for studies in the Spanish State.
- 7.- Be pre-enrolled in a blended degree.

In accordance with the call, the beneficiaries must accept the concession in writing. The maximum term for acceptance is 15 calendar days following communication of the resolution. Likewise, the beneficiaries must comply with all the obligations established in the call.
